


**AGENDA FOR MEETING OF THE BOARD OF DIRECTORS

Notice is hereby given that the Board of Directors of Reinvestment Zone Number Twenty-Six, City of Houston, Texas (the "Zone"), along with the Board of Directors of the Sunnyside Redevelopment Authority, City of Houston, Texas (the "Authority"), will hold a regular meeting on **Friday, April 11, 2025, at 12:00 p.m., at the offices of Allen Boone Humphries Robinson, 3200 Southwest Freeway, Suite 2400, Blanco Conference Room, Houston, Texas 77027**, with supplementary access via Zoom teleconference and/or videoconference, to consider, discuss and adopt such orders, resolutions or motions, and take direct or indirect actions as may be necessary, convenient, or desirable with respect to the following matters:

1. Establish quorum and call to order.
2. Approve minutes.
3. Engineering matters, including approve engineering proposals, authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve letter financing agreements, approve pay estimates and change orders, and authorize final acceptance of projects, as appropriate for:
  - a. gateway treatment and intersection improvement projects; and
  - b. Heritage Green project.
4. Report on development.
5. Reports on projects, including approval of agreements, proposals, and task orders, as appropriate, including:
  - a. UP Art Studios – art installation project; and
  - b. Harrison-Kornberg Architects – Sunnyside Community Center and Park.
6. Administrator’s Report, including:
  - a. website matters;
  - b. update on Zone Outreach Plan; and
  - c. update on Harris County Precinct 1 CPTED.
7. Review of financial matters, including reports, current payables, and budget for fiscal year end June 30, 2026.
8. Public Comment.\*
9. Meeting schedule.
10. Convene in Executive Session to: (i) discuss purchase, exchange, lease, or value of real property pursuant to Section 551.072, Texas Government Code, and (ii) consultation with attorney pursuant to Section 551.071, Texas Government Code.

11. Re-convene in Open Session and authorize appropriate action.
