Chair’s Report, David Bucek, Chair, announced speaker rules and meeting procedures.

Director’s Report, Robert Williamson, Secretary and Deputy Director for the Planning and Development Department, provided several updates. The Planning Department hosted a public hearing on March 24 to review and solicit comments for the proposed Norhill design guidelines; all comments are being reviewed and evaluated and will be posted for final hearing and vote at the May 21st HAHC meeting next month. Staff instituted a hard cutoff date for applicants to submit additional information so staff, commissioners, and the public have time to review before the upcoming meeting. The cutoff date is the end-of-day on the Wednesday one week before the next HAHC meeting. Applicants are allowed to present additional information at the HAHC meeting the following Thursday whereby Commissioners may accept and consider that additional information, or defer the application to allow for further review. The change also allows commissioners to abstain for conflicts of interest. For the current review cycle, the department

received 9 Pre-Application Design Reviews and 40 new COA applications, bringing YTD total for Pre-Designs to 20 and YTD COAs to 99. 10 Administrative Approval applications approved this cycle, bringing YTD of AAs to 22.
