III. CONSIDERATION OF AND POSSIBLE ACTION ON AN APPEAL OF THE DECISION OF THE HOUSTON ARCHAEOLOGICAL AND HISTORICAL COMMISSION (HAHC) ON NOVEMBER 6, 2025, DENYING A CERTIFICATE OF APPROPRIATENESS (COA) FOR A NEW CONSTRUCTION OF A GARAGE AT 2903 HOUSTON AVENUE IN THE GERMANTOWN HISTORIC DISTRICT.

Commission action: Motion to approve the applicant's request as submitted. Qualifying, the applicant has made reasonable concessions since the initiation of the process in August and has demonstrated substantial neighborhood support. The proposal is consistent with the character and intent of the Germantown Historic District and surrounding areas, including Woodland Heights and the Heights, where porches and balconies are commonly encouraged design elements. The proposed balcony is located on the garage portion of the structure, which is minimally visible from the public right-of-way on this corner lot. Additionally, the adjacent property includes a two-story garage apartment with a second-floor balcony, further supporting the compatibility of the request.

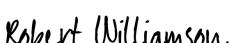
